LIFT REFURBISHMENT & UPGRADE

WBC Ref: C7086

Dear Resident,

As per our previous letter dated 31st July 2023 in which we had informed you of the planned lift refurbishment works and providing both start & completion dates for each lift.

Unfortunately, we have been informed by the onsite engineers that additional works are now required to landing architraves resulting in a 4-week delay to the original completion date. The lift contractors had advised that when they were replacing the existing landing door headers and door running equipment, the concrete walls around the entrance have crumbled away caused by vibration from drilling into the walls and distorting the structure of architrave frames.

On 16th November 2023 a joint inspection was carried out with the lift contractor, consultant, and the council. Unfortunately, due to the extent of damaged found around the landing entrances, the existing landing architraves need to be replaced with new. We have instructed the contractor to proceed with these works.

Due to additional works now required to lift H116, the completion has now changed to the **18th December 2023.** This has also resulted in the start dates for the next phase of works to be altered. It has been agreed that all lifts will remain in service over the Christmas period, then works to lift H115 will start in the new year. The contractor has advised that they will do their upmost to reduce the length of time the lift is shut down for.
